Notice of Privacy Practices

This notice describes how your medical information may be used and disclosed, and how you receive access to information. Please review it carefully.

Your rights

When it comes to your health information, you have certain rights. This section explains your rights and some of our responsibilities to help you. You have the right to:

Receive a copy of your medical record

- You can request to see or receive a copy of your medical record and other health information.
- We will provide a copy or summary of your health information, usually within 30 days of your written request.

Ask us to correct your medical record

- You can request Eden to correct health information that you believe is incorrect or incomplete.
- If your request is denied, we will provide you with a written explanation within 60 days.

Request confidential communications

- You can request that Eden contact you in a specific way (for example, home or office phone) or to send mail to a different address.
- We will comply with all reasonable communication requests.

Ask us to limit what we use or share

You may request that Eden not share certain health information for treatment. We are not required to agree to your request, and we may deny your request if it would affect your care.

Receive a list of those with whom we've shared information

- You can request a list (accounting) of the times we've shared your health information for six years prior to the date you ask, who we shared it with, and why.
- We will include all the disclosures except for those about treatment and healthcare operations, and certain other disclosures (such as any you asked us not to disclose). We will provide one accounting a year for free but will charge a reasonable, cost-based fee if you ask for another one within 12 months.

Get a copy of this privacy notice

You can request a paper copy of this notice at any time, even if you have agreed to receive the notice electronically. We will provide you with a paper copy promptly.

Choose someone to act on your behalf

- If you have given someone medical power of attorney or if someone is your legal guardian, that person can exercise your rights and make decisions related to your health information.
- We will confirm the person has this authority and can act for you before we take any action.

File a complaint if you feel your rights are violated

- You can file a complaint if you feel we have violated your rights. This is done by contacting us using the information on page 1.
- You can file a complaint with the U.S. Department of Health and Human Services Office for Civil Rights by sending a letter to 200 Independence Ave, S.W., Washington, D.C. 20201, calling 1-877-696-6775, or visiting www.hhs.gov/ocr/privacy/hipaa/complaints.
- We will not retaliate against you for filing a complaint.

Your choices

For certain health information, you have choices in the way we use and share your information. You have the right to either approve or decline:

- Sharing information with your family, close friends, or others involved in your care
- Sharing information in a disaster relief situation
- Including your information in a hospital directory
- Providing mental health care
- Marketing our services. We will not share your information unless you have provided permission in written form.
- Raising funds for our nonprofit clinic. We may contact you for fundraising efforts, but you can request Eden not contact you moving forward.

Our responsibilities, uses, and disclosures

Aside from the requests made by our patients and clients, Eden Clinic has a responsibility to abide by state and federal laws in preserving your safety and health information. This section outlines the ways in which Eden can or is required to share patient information. We may use and share your information as we:

Provide care to you

Example: A doctor treating you for an injury asks another doctor about your overall health condition.

Run our practice, improve your care, and contact you when necessary

Example: We use your health information to manage your treatment and services.

Help with public health and safety issues

We can share your health information for certain situations such as preventing disease; helping with product recalls; reporting adverse reactions to medications; reporting suspected abuse, neglect, or domestic violence; and preventing or reducing a serious threat to anyone's health or safety.

- Conduct medical, program, and health research
- Comply with state and federal laws, including with the Department of Health and Human Services if required to confirm that Eden is complying with federal privacy laws

- Respond to organ and tissue donation requests
- Work with a medical examiner, coroner, or funeral director
- Address workers' compensation, law enforcement, and other government requests, including health oversight agencies and special government functions such as military, national security, and presidential protective services
- Respond to lawsuits and legal actions, including a court or administrative order, or a subpoena

In some instances, we are required by law to share your information, usually in ways that contribute to the public good, such as public health and research. For more information, see www.hhs.gov/ocr/privacy/hipaa/understanding/consumers/index.html.

Our responsibilities

- We are required by law to maintain the privacy and security of your protected health information.
- We will let you know promptly if a breach occurs that may have compromised the privacy or security of your information.
- We must follow the duties and privacy practices described in this notice and give you a copy of it.
- We will not use or share your information other than as described here unless you tell us we can in writing. If you tell us we can, you may change your mind at any time. Let us know in writing if you change your mind.
